<u>Treasurer report</u>: Checkbook balance 01/03/2019 \$2,891.00. 04/25/2019 accounts balance was \$3,535.35. Ken opened a savings account for the majority of the balance so Friends FRT could earn some interest.

<u>Sunset Park update:</u> Trevor reported that the Village of Allouez is continuing to combat invasive plants in the section of park at the south end between the river and the FRT. They do not have immediate plans for the area.

Connection from Mountain Bay to FRT: No one at the meeting had any information on this topic.

Brown County Parks report from Nikki Hilker:

The majority of the sign project has been completed and paid for. A kiosk still needs to be built at the Calumet, Brown County line. That will be done in 2019. Some of the signs seem to be quite high in the kiosk. Not sure if they can be lowered or if they should. Becky and Nikki will look into it.

Parks staff have been busy repairing the flood damage at Pamperin Park. Ice took out much of the playground equipment and damaged the bridge and the shelter.

Brown County Parks gets many requests to use the FRT for events that include a large group of people. It is getting hard to balance the needs of the large group with the needs of individuals using the trail at the same time. The WI State Park System, Trail Division has told Brown County they can't continue to approve more than 2-3 large group events each year. So expect to see only a few big events on the FRT this year.

Nikki did not have an update on the parking lot parcels that may be available soon in the town of Rockland. She will update us at the next meeting.
